Engagement Manager captures critical input which is managed and visualized in context within the RIVAS system for better project information management.

CAPTURE

Issues and concerns recorded and connected to stakeholders in real-time during engagement meetings.

ACCESS

Stakeholders can view and enter key information e.g. local knowledge directly within the RIVAS system.

CONTEXT

Visualize and review issues in-context linked to ReportViz with location, date, content and information available.

MANAGE

Stakeholder information, meeting time and location linked with issues, tasks and status via Document Manager.

COMMUNICATE

Engagement continuity is important. Two-way email correspondence is tracked per issue and stakeholder.

ENGAGEMENT MATTERS

It spans from early project planning through permitting, construction, operations and even into decommissioning. At all stages, input from community, Indigenous partners, shareholders and the general public is critical to successful development.

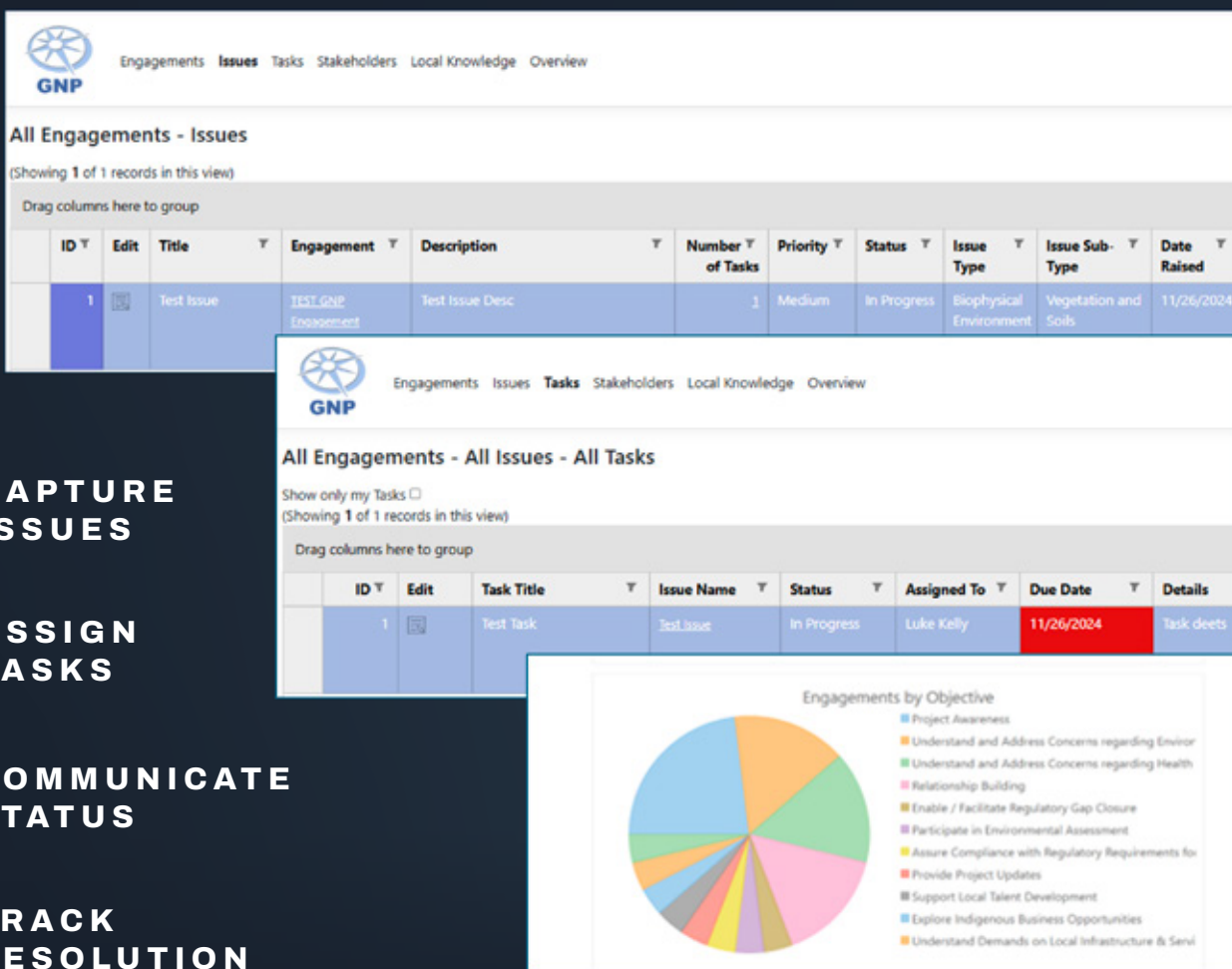
